General Park Procedures

1. The park opens daily at 9:00 AM (no earlier)! Please follow the schedule carefully according to trips.
2. The schedule is subject to change if necessary.
3. Payments for all trips are to be made in cash the day of the trip unless otherwise noted (see Pirates on the Manasquan)
4. Trip participants should sign up early to avoid missing the deadline because of vacations, illness or other events.
5. Children should arrive at the park 30 minutes prior to trip departure time to allow for group organization and a final head count.
6. Children may only register at **one (1)** of the township's parks (Clune, Hebrew, or Huffy).
7. Children should be wearing sneakers when playing sports

The sign-in/out policy is as follows:

- Upon arriving at the park, children will sign in and be given a numbered wristband that corresponds with our sign-in list.
- When signing out, the child must be accompanied by an authorized adult (**who must show identification**) or be authorized to leave the park. Always check the child's liability form, regardless of whether you know the parent or not.
- Upon approval, the child may have their wristband cut, hand stamped and sign-out time noted on our sheet.

The discipline policy is as follows:

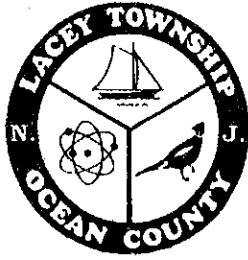
First Offense – Verbal warning, fill out discipline log, highlight name on sign-in sheet and initial, notify parents.

Second Offense – Fill out discipline log and discipline report, highlight the child's name on sign-in sheet and initial, notify supervisor who will notify parent / guardian of consequences.

Third Offense – Fill out discipline log and discipline report, highlight child's name on sign-in sheet and initial, notify supervisor who will notify parent / guardian of consequences and possible suspension and/or expulsion from the summer program.

There will be NO refunds for any child removed from the program for behavioral or disciplinary reasons.

1. Any kind of physical altercation between children will result in an automatic suspension from the park supervisor for one day (ex. kicking, tripping, punching, etc.).
2. If a child is caught stealing or being discriminatory to a child due to their race, they will automatically be suspended for one day by the park supervisor.
3. Children may not gamble or trade cards while at the park.
4. Children **MUST** wear their wristbands at all times. If a child removes it, he/she will be written up.

In the event of inclement weather, the Parks Program will be held at Lacey Middle School (660 Denton Avenue, Forked River).

In the event of inclement weather before 9 AM:

- The Recreation Department will make a decision by 8:30 AM. If the program is moving to the Middle School, notification will be made via our Weather Hotline and Facebook page.
- Parents must arrange for transportation to and from the Middle School. Program hours remain 9 AM-3 PM.

In the inclement weather later in the day:

- The Recreation Department will decide whether it is necessary to move the program to the Middle School. Notification will be made via our Weather Hotline and Facebook page.
- If the program is moving, the Recreation Department will bus children to the Middle School.
- **All children must be picked up at the Middle School by 3 PM.**

* On the days that the program is moved, scheduled trips will depart from the Middle School.

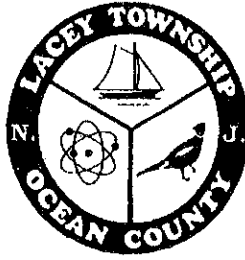
Please do not assume that the parks program will be held at the Middle School in the event of inclement weather. Variables such as the intensity, length, and time of inclement weather will help determine our decision.

Please note- If the program is moved to the Middle School at any point during the day and the weather clears up, WE WILL NOT RETURN TO THE PARK. All activities will remain at the Middle School. Children must be picked up by 3 PM.
